In the name of God Amen ~ I William Stanfield of Abbeville District & State of South Carolina, being afflicted in body But of sound disposing Mind and memory, calling to Mind my mortality do here make my last Will and testament, hereby revoking all my former Wills.

Imprimis, I bequeath my soul to God (in humble hopes of his mercy through Jesus Christ) and my body to the Earth as tuching my Worldly Estate which it hath pleased God to bless me With, I give and bequeath in the following Manner at the discesion of my Executors

Item, I will that my well beloved wife Sarah Stanfield do peaceably and Quietly, Enjoy all my estate Both real and personal during her Natural life, and then to be divided as I shall hereafter nominate, to wit. I will that fifty dollars be paid to my son John Stanfield at the discesion of my executors

Item I will that my Negro Titus shall have the privilege of Choosing his master on the following conditions, that is to say, the said person that Titus doth choose for his Master [after the decease of my wife] shall pay to my executors the appraisment of said negro, appraised by two disinterested persons- which said money to be Equally divided amongst the after named legetees

Item I will that all the ballance of my estate both real and personal be equally divided between the after named Legetees, To wit, Robert Stanfield, Jane Hitt, Peggy Miles and Milley Link

Item I give to Thomas Link five shillings, to be paid after the decease of my beloved wife Sarah Stanfield, at the descrecion of my executors -

And I do hereby disallow, Revoke, Disanull all and singular every other form or forms, wills and bequeaths by me in any manner or case before mentioned. One possibility for your ancestor would be George R. Stanfield who was in the Sand Mountain area ca 1835-1858. George R. Stanfield was a son of Rev. War soldier John Stanfield who married Sarah Roberts. She received Widow's pension #6215. I found a record of George R. having divorced 1827 in Newton Co., GA from Elizabeth, "a non-resident", Newton Co., GA. Superior Court. Also notice was in Southern Recorder, Milledgeville, GA 12-3-1827. George's mother Sarah was living with him in Bellefonte, DeKalb, Jackson Co., AL in the mid 1830s. George was in Hendricksville/Hendrixville, Southern DeKalb Co. AL in

1852 (not far from Etowah Co.); Marshall Co. 1854, in Madison Co., AR 1859. 1850 U.S. Census, DeKalb Co. p 353 lists: George R. Stanfield 49 M (p.o.b. Unknown); Ireny 36 F b GA; Pulaski D. 16 GA; Sarah E. 14 AL; Parthena E. 11 AL; Emily M. 9 AL; William W. 7 TN; Anna J. 4 TN; Sarah E. Stanfield 92 VA. From the letters in Sarah's pension file, George R. appears to have been well educated. This is not my direct line, and have not researched later descendants, but was searching for a connection to my David Stanfield and wife Elizabeth "Betsy" who were in Jackson Co., AL by 1819 or earlier.

For ancestors of Russell Robert Stanfield, you may want to get the Rev. War pension file of Capt. John Stanfield's widow, Sarah (nee Roberts) Stanfield. Their son, George R., was living for some time in Marshall & Etowah Cos., AL. His widowed mother Sarah Stanfield lived with him. There are many letters in the file written by George R. George R. lived in GA, AL, MS, AR, then I understand may have returned to AL.

Was hoping you had evidence of my brick wall David, b ca 1790, on Jackson Co., AL U.S.C. 1830. Wife Elizabeth "Betsy" b ca 1795 KY or TN a founding member of Mud Creek Baptist Church of Christ in Jackson Co., AL 1819, living Shelby Co., AL 1850, No AL later. Looks for all the world like the (Quaker) David & Betsy Beals/Bailes Stanfield m 1815 WC, TN and removed to Indiana, but am told it's not.

From 'The Hollingsworth Collection', on microfilm at Wallace State Community College, Hanceville, AL, I found a record of divorce: George R. Stanfield: "Rule nisi, Newton Co. Ga. Superior Court, in re George R. Stanfield vs Elizabeth Stanfield, petition for divorce. Defendant Elizabeth is a nonresident. - Notice in SOU. RECORDER, Milledgeville, 12-3-1827."

George R. who divorced Elizabeth in Newton Co., GA Superior Court could be one & same as married to Irene. It's certainly possible; Ireny was age 36 in 1850 (born 1814); considerably younger than George, on DeKalb Co., AL U.S.C., page 353. The number for her age isn't that easy to interpret, and you really have to compare letters. It looks like either age 26 or 36 - but she surely didn't have eldest son Pulaski D. at age 10. They probably married sometime between 1828-1833.

The wife is alleged by some researchers to be his second, named Irena Pulaski Davenport, hence the name of the son shown here.

As one can see from the birthplaces of the children, this family moved around a bit. Mary Lu Johnson has posted on GenForum that she has found a record on microfilm showing from publication in the \_Southern Recorder\_, Milledgeville, GA, 3 Dec 1827, George R Stanfield filed for divorce from his first wife Elizabeth in Newton Co, GA Superior Court. Defendant was a non-resident [of Newton County ??].

The Census finding noticed above is quite nice. When Sarah Roberts applied for a RW pension as widow of John Stanfield in 1835, she specified that she was living with her son George. She survived until 1854 and thus the Census finding definitively proves who this George was.

John Stanfield was one of two elected representatives from Randolph County to the NC General Assembly held at Tarboro (now in Edgefield County) in Nov-Dec 1787. The other representative from Randolph being Edmund/Edward Waddell. They were sworn in on Nov 19, 1787. On the 27th John presented a petition of Alexander Smith and Baptist Clark, and also presented the resignation of Nathaniel Stead as one of the Justices of the Peace for Randolph County. The rest of the citations are Nov-Dec 1787 votes for or against certain petitions or bills. In any case, we once again find Capt. John ranging far afield of his Randolph County homestead.

John Stanfield was a Revolutionary War Captain. He and his wife, Sarah Roberts Stanfield, had at least 12 children. John and Sarah Roberts were married by the Rector of the Protestant Episcopal Church.

John entered the Revolutionary War from Guilford County, NC as a Private, promoted to Lieutenant, and to Captain under the command of Captain Arnold, Major Crump and General Caswell. He served from the time he entered until the close of the war. He was in the Battle of Guilford County Courthouse. After the war, John lived in Randolph Co., NC (formerly a part of Guilford County, NC). In 1787 he was an elected member of the House of Commons of the General Assembly of North Carolina, representing Randolph County. Some years later, he moved to what was known then as Abbeville District, SC, today this is

Laurens County, SC. John died in Laurens on 11-08-1805.

After John's death, his widow, Sarah moved to Murray County, GA, to live with her youngest son, George R. Stanfield.

This information was obtained from an application for a pension (Pension \*W6215) which Sarah made July 12, 1848 based on the fact that her husband was an officer and served in the Rev. War. The pension was effective March 4, 1848 in the amount of \$93.33 per annum. This record is in the National Archives in Washington, D.C. The record also states that Sara resided with her son George R. Stanfield in Dalton (Murray Co.), GA on July 12, 1848. In 1849, this son's address was Van Buren (DeKalb County), Al. She was living with him on Sand Mountain in Marshall County, Alabama, when she died on February 3, 1854. Sarah was 97 years old.

You would have to look at the Court records of Halifax, Co., [VA, I presume] to determine what precipitated the writ ordering the Sheriff of Randolph Co, NC to sell these properties. It could result from any kind of judgment including divorce and/or confiscation for participation in losing side of Revolution. Thus you would need to check to know the particulars and they might be different for each individual named.

The writ is referenced in the deed to prove that the sheriff had the right to sell the property in question. The writ covered both real estate and chattels. Chattels are generally used as a legal term to describe personal property or movables as opposed to real estate (or land which is not movable, of course). It is a catchall that could have covered livestock, wagons, tools, crops, furniture, etc.

It is possible, I suppose, that upon removing to South Carolina, Capt. John executed a Power of Attorney, which he left in hands of some relative in Halifax County. The P of A would have given them legal authority to sell or otherwise dispose of John Stanfield's remaining property in Randolph Co., NC. That person may have then gone into Court in Halifax County and using the Power of Attorney, convinced a Judge to sign a writ to have the local Sheriff in NC handle the situation.

When Sarah Roberts applied in Murray County, GA, for a RW pension as widow of John Stanfield in July 1848, she specified that she was living with her son George. She survived until Feb 3, 1854. He son George applied in Marshall County, AL, for letters of administraytion of her estate, for which he posted an \$80 bond - "about twice the value of the estate".

1. I know the GenForum stuff says Sarah R. applied for her pension in 1835, but (as you will see) her application was in 1848 - not 1835. One of the acts granting pensions to indigent widows was in 1835 - maybe that's the source of the confusion. That solves the problem of her not being in George's 1840 household, but doesn't explain where she was in 1840. Musta been with one of her other kids.

2. 1840 Hickman is indeed odd. Gotta be her grans - but who the parents are is beyond the scope of my crystal ball. One hipshot assumption could be that The Crankster's parents were dead, and that this is Sam and sisters, but that would not be consistent with Sarah being one of the 8 children of Sarah R Standfield still alive in 1848. Don't know what to make of this yet. We have some decent TN/Maury and/or Hickman records - I forget which, has been a couple years since I looked at them - that I'll get into this weekend.

3. Agree that Robert was dead by 1800. Since Jane said Robert was younger than her, and William said Robert was older than he/William, I assume Robert could have been between Jane and William, but that would work only if Jane turned 63 in 1848 - but after her deposition - and was therefore born in 1785, with Robert in 1786 and William in Feb 1787. If Jane was born in 1785, as seems likely, then Sarah was born NLT 1784. In any case, Robert was fer sure a gonner by 1800, and the GenForum info of his birth as c1799 was just an uninformed guess. That calls into question the other estimated years of birth, with the exception of Jane, because hers is based upon something solid. We have the actuals for Elizabeth, William and Frances.

4. Sarah d/o John & Sarah was married by 1800. Depending upon when she was born in the 1779-84 time frame, I would guess her marriage to be 1795-1800. The Crankster must have siblings, and probably several - assuming we have the

right Sarah Stanfield! Sam was probably one of the youngest (if we are to believe his approx. year of birth as c1814), and could have named his kids after some of his siblings - especially the daughters.

5. These Stanfields owned no slaves. Neither did Cranky, as we know from census records and now also from the AR/Izard tax records for 1861, in which he was taxed for his land, one horse and himself. These Stanfields moved around a lot after John's death - so did Cranky. So far, everything fits ... but "so far" ain't exactly what we're trying to accomplish. Still, it's encouraging. Maybe we can triangulate Har\*1-Stanfield-Watson in the early/mid 1830s, assuming Crank & Margt married 1835-36. Hickman and vicinity looks like a good place to start, altho the apparent high degree of mobility of these folks makes them awfully slippery.

#### Timelines:

According to affidavit of Jane (Stanfield) Ewing filed July 5, 1848 in Tallapoosa County, AL, she was the fifth child born, including an unnamed infant who died in infancy. Jane was age 62 at the time of the deposition (thus born c1786). Her older siblings were Elizabeth (born in Jan 1778), Richard (who married Martha Grimes - she lived in Georgia after his death), Sarah and the infant. The family moved from Randolph Co NC to SC Abbeville when Jane was nine - thus about 1795. Her younger siblings were William, Polly, John, Peter, James, Robert, George and Frances.

All of these 8 children lived to maturity, with the exception of Robert, who died at about age nine. All of the remaining 7, six were still living at the time of Jane's affidavit, the exception being Peter. In short, at the time of Jane's July 1848 deposition, 2 of her 8 younger siblings were no longer alive, and 2 of her older siblings - Richard and one other - were no longer alive, unless Jane has factored out the unnamed infant. From the affidavit, it is not entirely clear whether "all lived to maturity" applies to just Jane's younger siblings, or to ALL of her siblings, but from other testimony, it appears that all, with the exception of the unnamed infant and Robert, lived to be adults. And that means daughter Sarah lived to maturity.

Jane's younger brother William also filed an undated (presumably 1848) affidavit, in Wayne County, TN, in which he said he was then 61 years old, and was born on Feb 2, 1787 (he would therefore have been 61 years old in 1848). He said his parents had ten children (who he named) beside himself (he forgot about older sister Elizabeth and the unnamed infant). Older siblings were Richard who married Martha Grimes, Sarah, Jane and Robert (!), and six younger siblings - Polly, John, Peter, James, George and Frances. All siblings lived to maturity except Robert who died at age 9. All the others were still living, except Richard and Peter, at the time of the affidavit.

The significance of this is that, in mother Sarah's July 1848 pension application submitted in Murray County, GA, she says that she had twelve children (evidently excluding the one who died in infancy), and that ten lived to maturity (Robert did not, according to prior affidavits by Jane and William, and one other evidently did not) - Sarah also declared that eight of the children were still alive. We know that Richard, Robert and Peter were already deceased by 1848, according to the affidavits of Jane and William. I assume that the oldest, Elizabeth, was also not alive in 1848, because William did not name her as a sibling, suggesting she had been dead for some time. That means that daughter Sarah was probably also still alive in 1848. If so, and assuming she lived to 1854, then she and her heirs would be legal beneficiaries of her mother Sarah's estate (no matter how small the estate), which I assume was administered in Marshall County AL, because that is where George Stanfield filed for letters of administration in 1854.

#### Other thoughts:

The daughter Sarah must have been born 1780-85. The family moved to SC by 1794, where they lived until at least 1805, and possibly a few years after. It is not clear when the widow moved to Georgia, or who went with her. My guess is that daughter Sarah was married in SC if she was in her early 20s - if she was married later than that, anything is possible. Would recommend finding these Stanfields in Abbeville District in 1800 and maybe 1810 and see how the daughters in family structure shapes up. Of the five daughters, we

have:

Elizabeth born 1778

Sarah born 1779-85

Jane born 1786 who married a Ewing

Polly born c1790 who married James West

For some time it appeared Sarah might have been the mother of Samuel Harvell who married Margaret Watson, but it now seems unlikely...

#### THE SARAH STANFIELD/JAMES MILLER MARRIAGE

I came into possession of Dad's papers a couple of years ago and among those papers was a note that Samuel Harwell/Harvell's mother was Sarah Stanfield. Try as I might, I couldn't find a source for this note except for a vague reference about an IZARD County Historian article by a descendant of George Lafayette "Uncle Fayette" Harvell. Our dear cousin, Kay Peterson, has done an exhaustive search of all the back issues of the Historian without finding any reference to this fact.

Quite some time ago Stewart Stanfield informed me that Wesley Smith had said that Sarah was married to James Miller in South Carolina. I contacted Wesley and he said that his source was one Margaret Moffitt. I was never able to make contact with Margaret.

So, I was left with a mystery. If Sarah married James Miller, how could she be Sam's mother?

We do know that there is a relationship with Sarah's brother William in IZARD County and that he married (at a considerable age) to the relatively young widow of William A. Watson. William A. Watson was the brother of Margaret Watson who married our Samuel Harvell. We also have record of several of William's descendants in the IZARD and Stone county area of north Arkansas. We know that a descendant of Sarah's brother John married Stephen H. Moss in IZARD County. Stephen H. Moss was the brother of my great-grandmother, Mary Frances Moss who married William Harvey Moser and Sarah Elizabeth Moss who married Samuel "Wilson" Harvell. Stephen's wife was Mary F. "Molly" Stanfield, the daughter of William Stanfield and Elizabeth Woody. This younger William Stanfield was the son of John S. Stanfield, Sarah's brother.

We know from the 1860 and 1870 IZARD County census that this was William Stanfield, a Baptist preacher, and that the family of William A. Watson was in his household in 1870. And the above indenture proves that Mary and he were man and wife.

Here is what I have found:

It is a well established fact that Sarah's grandparents were William and Sarah Roberts. We have 'deed of gift' records from Halifax County, Virginia, that identify three of their daughters and their husbands. It is clear from other research that the wife of Richard Shackelford was another:

- Miller, Haman Roberts, Frances Deed of gift, William Roberts to dau. Frances Miller and husband Haman Miller, 1778. DB 8, p. 116.
- Miller, Jacob Roberts, Martha Stovall Deed of gift, William Roberts to dau. Martha Stovall Miller and husband Jacob Miller, 1778. DB 11, p. 4.
- Stanfield, John Roberts, Sarah Deed of gift, William Roberts to dau. Sarah Stanfield and husband John Stanfield, 1777. DB 10, p. 154.
- Additionally, William's daughter, Mary, married Rev. Richard Shackelford.

John Stanfield and Sarah Roberts are, of course, the parents of Sarah who is the focus of this research.

Haman Miller, who married Sarah's aunt Frances "Fanny", is the father of James Miller who was said to have married Sarah. Haman Miller's will names his wife and children:

In the name of God amen. I Haman Miller Senr of the County of Randolph and State of North Carolina, being very sick and weak in body but of sound and perfect mind and memory blessed be God. But knowing that it is appointed for all men once to die, do make and publish this my last will and testament, this twelfth of July in the year of our lord one thousand eight hundred and fourteen, in manner and form following (that is to say) principally and first of all I give and recommend my soul into the hands of Almighty God who gave it and my body to the earth to be buried in a decent and Christian manner, at the discretion of my executors, and as touching such worldly estate where-with it has pleased god to bless me in this life, I give devise and dispose of the same in the following manner and form (to wit) first--it is my will that a just and true inventory of my personal estate shall be made by my executors, and also that all of my just debts shall be paid out of the moneys on hand and if not a sufficiency that they be paid out of my personal estate as aforesaid-

Item-I leave for the use of my wife Fanny Miller all the tract of land whereon I now live with the plantation and improvement thereon, also all of my household furniture, plantation tools and stock consisting of horses, cattle, sheep, hogs, etc. except such part thereof which may be considered necessary to be sold and which she may not have particular need of, in order to discharge my just debts and other necessary expenses. Also I leave for the use of my beloved wife the following negro slzves (viz) ben, Frank, Sal, Ralp, Bob, Isaac, Danile and Ame. All the afore mentioned property both real and personal I say I use and benefit of her my beloved wife only for and during her natural life or widowhood, and then the afore mentioned property to devolve and become the property of my heirs and none other, to be equally divided between all of my children namely Peter Miller, Patty Fuller, wife of Archibald Fuller and Sally Wade wife of Henry F. Wade, except the land with its improvemtms and appurtenances as above mentioned which in case my beloved wife should live should marry or after her decease, I give and bequath as follows, first I give and bequeath to Jones F. Miller son and heir at law of my son Jacob Miller and Zella his wife, all that part of said tract of land lying east of a line drawn beginning at a sycamore the corner of my land upon the bank of Jackson's Creek running three poles up the hill to a dead pine thence nearly north to where the way leading from where I live to my still house crosses the Fayetteville road from thence a direct course, leaving the still house to the right hand to Archibald Fuller's line, whereone the plantation where my son Jacob Miller now lives with its improvements. I give to him the said Jones F. Miller to him and his heirs forever. Also I give to my son James Miller at the time of the marriage or the decease of my beloved wife Fanny Miller all of the part of the said tract of land lying west of a line drawn beginning on Jackson Creek where it intersects Haman Miller's line thence down the creek to my spring branch thene a direct course to the mine springs thence a direct course to the head of the draw of branch which runs down near the old meeting house and down said branch or drain to the mouth thereof and so a direct course to the line. I give to him and his heirs forever. Also I give to my son Jacob Miller at the time above mentioned all that part of my said tract of land, lying between the said lines as aforesaid and including the plantation whereon I now live with its improvements, I say I give and bequeath the same to him the said Jacob his heirs and assigns forever.

Item- I give and bequeath to Jones F. Miller son of the said Jacob Miller and Zella his wife one Negro girl named Zilpha to him and his heirs forever.

Item- I give and bequeath to my beloved son Peter Miller one Negro boy named Alex to him and his heirs forever.



Item-I give and bequeath to my son Thomas Miller one Negro boy named Wetty to him and his heirs forever.

Item-I give and bequeath to my beloved grandson Thomas Miller son and hier of the aforesaid Haman Miller and Frankey his wife one negro boy named Barton to him and his heirs forever.

Item-I give and bequeath to my son James Miller one Negro girl named Hannah to him and his heirs forever.

Item-I give and bequeath to my son Jacob Miller one Negro slave named Phil to him and his heirs forever.

Item-I give and bequeath to my beloved daughter Patty Fuller wife of Archibald Fuller one Negro woman named Jude to her and her heirs forever.

Item-I give and bequath to my beloved daughter Sally Wade wife of Henry F. Wade one Negro girl named Vine to her and her heirs forever. Likewise it is my will and desire that my tract of land lying on Jackson's Creek above William Ridge's containing one hundred acres to be sold to the highest bidder also my still and utensils thereunto belonging also be sold and the moneys arising therefrom the sales thereof to be applied to the use and benefit o my estate to defray the ordinary expenses that may accrue. Likewise it is my will and desire that the suit which is now pending in the Superior Court of Equity for the County of Randolph, wherein I myself am complainant and James Daniel and others are defendants should be prosecuted with effect. And in case a recovery is made against them thereone, that the profits arising therefrom be qually divided between all my children. Namely Peter Miller, Hannah Miller, James Miller, Jacob Miller, Patty Fuller wife of Archibald Fuller and Sally Wade wife of Henry F. Wade.

And I hereby make and appoint my beloved wife Fanny Miller Executrix and my beloved son Haman Miller and James Miller Executors of this my last will and testament. In witness whereof I the said Haman Miller SENr. the testator have hereunto set my hand and seal the day and year first above written.

Signed sealed and acknowledged by Haman Miller the Testator in the presence of us who were present with each other at the time of signing and sealing and acknowledging hereof.

It is plain to see that there is a close relationship between the Millers and the family of Sarah's mother and that Sarah and James Miller were first cousins. The following petition for divorce transcribed by my friend Susan Gall of North Carolina proves that James Miller and Sarah were married:

Millar, James and Gilly (Fullar), Petition of James Millar of Randolph County states that in the year 1792, he "accidentally happened to call at the house of Brittain Fullr of said county in the evening ...." said Fullar and his family engaged themselves in making "the petitioner so drunk that he was insensible of anything that passed, and while your petitioner was in that situation, the said Fullar....caused a magistrate, who was a brother to the said brittain Fullar, to consummate the marriage ceremony between your petitioner and a certain Gilly Fullar daughter to....said Brittain when your petitioner was so far intoxicated that he was...unable to stand without assistance..." The next morning, after you peitioner was informed of what had taken place, he "remonstrated with the said Fullar against the illegality of their proceedings...as he never had paid his addresses to the said Gilly Fullar or shown any signs of attachment to her." The said Fullar offered your petitioner a considerable quantity of property if the petitioner would acknowlodge said Gilly as his wife and live with her as a husband. Your petitioner rejected this offer and advertised the facts stated in this petition in different parts of said county, forewarning all persons from giving said Gilly credit on his account. Your petitioner removed to the state of South Carolina and remained there until the said gilly intermarried with Robert Arnold of said Randolph County, by whom she has had several children. Your petitioner, not considering himself bound by the fraudulent marriage to said Gilly, intermarried with SARAH STANSFIELD of South Carolina, who has borne him five children, vix., Alfred, James, John, Peter and Martin Millar. Upon being advised that the children may be considered illegitimate and deprived of their right of inheritance, your petitioner prays relief from his fraudulent marriage to said Gilly Fullar and a confirmation of his marriage to Sarah Stanfield, thus legitimizing the children. (Enclosures:) Depositions of Haman Millar, Esq., of Randolph County, 11 Dec. 1793, and of Rev. Richard Shackelford of Laurens County, South Carolina, 21 Aug. 1793, which support the details in James Millar's petition. (GASR Nov. - Dec. 1806, Box 2: folder "Petitions (Divorce, etc.).") Committee of Divorce and Alimony to whom was referred the petition of....James Millar of Randolph County's prayer for divorced recommend (his) petition be rejected. The following provides additional evidence that makes it very likely that the Sarah who married James Miller was indeed "our" Sarah, the daughter of Captain John Stanfield.

The following abstract appears to be concerning the same lawsuit and involves Sarah's brother William (Rev. Billy later of Wayne County, Tennessee and Izard County, Arkansas):

In the Asheboro Public Library there is a copy of a legal proceeding of November 4, 1808, at the house of Josiah Lyndon in Randolph County, apparently a circuit court proceeding. William Stanfield, grandson of William and Sarah Roberts, and the son of John and Sarah (Roberts) Stanfield, gave sworn testimony by answering questions from the plaintiffs and the defendant. William, who according to the document, was born on February 2, 1788, said that in the summer of 1807 he had lived in the home of Jacob Miller in Laurens County, South Carolina, and had been in contact with his grandmother, Sarah. Sarah possibly was living in the Miller home with her son-in-law and daughter, Jacob and Martha Stovall (Roberts) Miller. It is not known what Sarah's view of the mortgage was, but the plaintiffs, who were her son and her son-in-law, were trying to establish that she was so elderly that she was incapable of managing her business. William, in reply to these questions, said, I suppose she is.

That is Robert Arnold who married the rejected Gilly Fuller and James and Sarah with their two oldest boys. Sarah is listed as 16 to 26 years old having been born between 1774 and 1784. This fits what we know of our Sarah.

One can see in 1810 that Robert and Gilly are still in Randolph and James and Sarah in addition to the five sons named in the divorce petition now have 2 more. James Miller is not on the 1820 census of Randolph County and it appears that he may have moved back to Laurens County, South Carolina:

You may recall that Haman Fuller's daughter Patty married Archibald Fuller, I am uncertain of the

kinship between Archibald and Gilly who married James Miller.

There is this additional note from the research of Donald George Brown:

In 1829, 15 years after Haman's death there was in the Superior Court of Randolph County, North Carolina, and the Equity Court of Laurens County, South Carolina, a lawsuit of Haman Miller and James Miller, Exrs. of Haman Miller Deceased vs. Sarah Fuller, John Milam and wife Sarah, William Fuller, Jones Fuller, Patsy Miller, Peter Fuller, Jones Fuller and his wife Mary Ann, Archibald Fuller and Israel Fuller (Laurens County Equity Court, Box 14, package 14). It is from this long and labored document that the structure of the entire situation is revealed. The document was addressed To the Judge in Equity for the Supreme Court of Law for the County of Randolph, with Haman, Jr., and James claiming that the heirs of William Roberts were in possession of slaves which were collateral for the old deed of trust--the mortgage--the bond for William Cunningham and Company. The mortgaged slaves and some of their increase were named, some of which had been sold to individuals outside of the family. Haman Miller, Jr., and James Miller were asking the present owners to reimburse your orator what he has paid out.

I looked this suit up on Laurens County Equity Court index yesterday, January 30, 2003, and the index list Haman and Jacob (not James) as petitioners. I suspect that James was in Georgia based on the divorce record of George R. Stanfield (Sarah's brother) provided to me by Stewart: 1828 Feb 27 Newton Co., GA (Recorded Newton Co, Georgia, Superior Court Vault, Record Book 1827-1829)

This petition of George R. Stanfield humbly showed that he is at this time lawfully married to a woman whom maiden name was Elizabeth Camp now legally Elizabeth Stanfield but who has for a long time to wit known for this space of seven years contrary to the marriage contract with your petitioner and in violation of all law having as well as divided after leaving the bed and board of your petitioner without any the least provocation lived and is now living in the state of adultery (sic) with one Thomas Holden of said State and lived (sic) became the mother of several children by said illegal connection with said Holden. And your petitioner further charges that it was some time in the year Eighteen hundred and twenty that she left his house last and had never returned and had always refused to return and live with your petitioner and his wife by reason of which said petitioner is deprived of the comfort and convenience of the Society and Services of a lawful wife. Wherefore your petitioner prays a trial in conformity with the constitution and laws of this State in such cases made and provided to the end that your petitioner and the said Elizabeth Stanfield may be absolutely divorced from each other and prays that a citation ? may? upon regaining the said Elizabeth in person or by attorney to be and appear at the next Superior Court held for said County there and then to answer your petitioner in a libel for divorce. [s/s] Julius C. Alford

Testimony in the above case.

Peter H. Stanfield sworn says that he was present at the marriage of the plaintiff and defendant in South Carolina in Abbeville District. They lived together about a month and an half. When she left him without any provocation that he remembers staid out all night & returned the next day & has not lived with him since. Sarah Stanfield Sworn says that she lived with her saw that she knows of no provocation which he gave his wife to leave him. One evening when he was gone from home She walked out and I came home about dark dusk & he asked her where she had been. She replied she had been about & about & he asked her a second time where she had been & she replied that he had always gone when he pleased and she intended to the same. He then said perhaps she might go when she pleased but not come when she pleased. She than began ?the Witness Supposed to separate the cloths which hung on a pole he then spoke to her and said she aught not to do so. She then quit pulling down & went out and Witness saw her no more till next morning when she returned & went into his brothers house but did not come into her own where he was. He had been bleeding at the nose all night and did not expect to live they did not speak together. She after a little while went off & spent all day & came

home in the evening got her clothes & went off & never came back to him again of her own accord. He went & coaxed her home once but she would not stay with him. Witness has seen defendant sit & as many as twice and lament having left Thomas Holden with whom and his mother she had lived during her absence from her husband. JAMES MILLER sworn Says defendant had a house built about a mile from his witness residence [NOTE: "witness" was probably added for clarification here and in the testimony of Sarah; i.e. whose house? Witness', but they didn't use parentheses] and had seen her and Thomas Holden then together in the daytime. There was a child then she afterward moved a way out of the settlement since which time he had seen her with two children besides the one, which she had when he first saw her. He inquired for Holden and she said he was at home. Witness did not know of Holden having any other home besides the house of Defendant. Eli Thornton sworn says that he had seen her in the road with a child. She said that she was living with Holden & that the children were his. [s/s] Esq. Charles I. McDonald Judge

We find that sufficient proofs have been referred to our consideration to authorize a total divorce that is to say a divorce Vinci do matrimony upon legal principals between the parties in this case.

Registered 10th March 1827 [s/s] Charles Kennan, Foreman

Since the North Carolina Legislature denied the divorce petition between James Miller and Gilly Fuller, Sarah could have moved on and married a Harwell/Harvell, but I doubt it. It is clear that Robert Arnold and Gilly Fuller moved their family to Bedford County, Tennessee, so it is a safe bet that James never accepted that marriage.

Likewise, we know that George R. Stanfield married in South Carolina about 1820 and that James Miller was there at the time (we have that census record) living near George and that James later testified on his behalf in a Newton County, Georgia, divorce proceeding. I see no reason to believe this was not the James who married Sarah, or at least his son, this indicating that the James Miller family moved to Georgia along with the Stanfields. That being the case, it would appear that James and Sarah remained husband and wife at least until 1820/1829 and very likely longer.

If that is the case, it would eliminate Sarah as a possibility for the wife of Williamson Harwell and the mother of our Samuel who was born circa 1813.

It looks very much to me that the connection with the Stanfield family is (as I have suspected for some time) through our Moss and Watson families and not through the Harwell/Harvells ~Roger Harvell

According to a receipt for \$9 from William D McCracken for making a coffin and materials for the burial of David Eddleman, it appears he died in March 1829 without a will. Elizabeth and Moses Eddleman were issued letters of administration May 4, 1829, and posted a bond of \$4,000 secured by Richard Stanfield, William Moore, Charles M .Berry, Barnabas Pace and Richard Kennon Jr. In July 1829 John Eddleman was appointed administrator, and posted a \$4,000 bond secured by Jordan Thomaston, John Webb, John Witcher and Thomas Baker. An inventory was made Jul 7, 1829, and they held the estate sale the next day. Land and one negro woman were sold Jan 5, 1831 – Charles Sanders bought 52 acres Lot #102 9th district formerly in Henry, now in Newton County for \$380 ... Archibald E Lard bought 41 acres for \$201 ... Jacob Harman bought 49 acres for \$300 ... David Eddleman Jr. bought the old negro woman for \$104.

On July 1, 1833, Elizabeth Eddleman was appointed Guardian of Elijah Eddleman, a minor son of David Eddleman dec'd. Elijah was over 14 years of age when he chose Elizabeth as his guardian. The reason given for being so late in appointing a guardian for Elijah was because the administrator, John Eddleman, was distributing the money in the estate. As one can see from the birthplaces of the children, this family moved around a bit. Mary Lu Johnson has posted on GenForum that she has found a record on microfilm showing from publication in the \_Southern Recorder\_, Milledgeville, GA, 3 Dec 1827, George R Stanfield filed for divorce from his first wife Elizabeth in Newton Co, GA Superior Court. Defendant was a non-resident [of Newton County ??].

The Census finding noticed above is quite nice. When Sarah Roberts applied for a RW pension as widow of John Stanfield in 1835, she specified that she was living with her son George. She survived until 1854 and thus the Census finding definitively proves who this George was.

Peter H. Stanfield sworn says that he was present at the marriage of the plaintiff and defendant in South Carolina in Abbeville District. They lived together about a month and an half. When she left him without any provocation that he remembers staid out all night & returned the next day & has not lived with him since. Sarah Stanfield Sworn says that she lived with her saw that she knows of no provocation which he gave his wife to leave him. One evening when he was gone from home She walked out and I came home about dark dusk & he asked her where she had been. She replied she had been about & about & he asked her a second time where she had been & she replied that he had always gone when he pleased and she intended to the same. He then said perhaps she might go when she pleased but not come when she pleased. She than began ?the Witness Supposed to separate the cloths which hung on a pole he then spoke to her and said she aught not to do so. She then quit pulling down & went out and Witness saw her no more till next morning when she returned & went into his brothers house but did not come into her own where he was. He had been bleeding at the nose all night and did not expect to live they did not speak together. She after a little while went off & spent all day & came home in the evening got her clothes & went off & never came back to him again of her own accord. He went & coaxed her home once but she would not stay with him. Witness has seen defendant sit & as many as twice and lament having left Thomas Holden with whom and his mother she had lived during her absence from her husband. James Miller sworn Says defendant had a house built about a mile from his witness residence [NOTE: "witness" was probably added for clarification here and in the testimony of Sarah; i.e. whose house? Witness', but they didn't use parentheses] and had seen her and Thomas Holden then together in the daytime. There was a child then she afterward moved a way out of the settlement since which time he had seen her with two children besides the one, which she had when he first saw her. He inquired for Holden and she said he was at home. Witness did not know of Holden having any other home besides the house of Defendant. Eli Thornton sworn says that he had seen her in the road with a child. She said that she was living with Holden & that the children were his. [s/s] Esq. Charles I. McDonald Judge

I might mention that in the George Stanfield divorce petition - where his wife has been transcribed as Elizabeth Camp - after studying the handwritten document I think it should have been transcribed Canup. This I believe is a corruption of Knop. I think she was a dau. of Charles Knop (sometimes Knopt) of Abbeville, S.C. There are records where he left money to one Elizabeth Stanfield. A son of Charles, Frederick, came to GA. where he was often listed as Canup. Thanks again.

The following are the minutes of the 23rd annual meeting of the Rocky Bayou Association of Lunenburg, Arkansas, September 25, 1863:

The Rocky Bayou Association convened according to appointment with the Rocky Bayou Church, IZARD County, Arkansas. Introductory sermon by Elder Duren. Roman 6 Chapter 27 vers.

The Association was called to order by Edler (William) Stanfield, former moderator. Called for letters from the churches.

After the reading of which, the association was organized by electing Elder Stanfield., moderator, and S. {sic-below it appears to be "J."} W. Cockran, clerk. Invited brethren in the ministry to seat with us which was accepted by Elder L.R. Furgeson of Yentry County, Missouri. Called for petetionary.

On preaching Elder Gun and Deacons of Rocky Bayou, finance, Bro. Hays and W. Moore. Adjourned until Saturday 9 p.m. prayer by moderator.

Saturday, September 26: Met pursuant to adjournment prayer by Elder Brown, called the roll, read the constitution and decorum. The rearrangement received adopted and committee discharged. Resumed inventation to correspondents none. Appointed correspondents none. Appointed correspondents to sister associations to Independence, J.H. Oldham to White River. Elder W. Stanfield on motion cease for the present to send correspondents to Black River, Concord, Union and Mt. Vernon associations. That the next meeting of the association be held with New Hope Church. Lawrence County, AR. Commencing on Sunday before the fourth Sabbath in September 1864. Elder Brown to preach the introductory sermon. On motion dispense with appointing anyone to preach missionary sermon and the taking public collection.

Adjournment to 2 p.m. During recess Elder Ferguson preached affable and interesting sermon. Met pursuant to adjournment prayer by Elder Duren, the report of the committee on finance received, adopted, and committee discharged. On motion the clerk to write and distribute a copy of the minutes of each of the churches and receive for his services the fund on hand \$25. Read and approved assembly, adjourned to the time and place above named.
