## Session Minutes Milton Presbyterian Church

Transcriber's notes: I have made no attempt to transcribe the entire body of the Session Minutes. Much of it is repetitive. I have attempted only to pull out information of a material nature—mainly names and dates of members, letters of dismission, and some disciplinary actions of the session.

- 1820 The Female Academy opened in Milton. The Rev. Abner Clopton, Baptist, was headmaster.
- 1822 Rev. Clopton moved to Charlotte Co., Virginia. He was succeeded by the Rev. Arch D. Montgomery, Presbyterian, who presided over the Academy and preached one Sunday in the month.
- 1823 Plan to build a church. Female Fragment Society [sewing circle] formed. Money was raised by various means. Mr. Montgomery removed to the Red House in 1823.
- 1825 By the fall, the Female Fragment Society had raised a sum of money and a contract was made with Mr. W. A. Royster to build a church. A subscription for a year's support of a minister went around and anyone who contributed more that \$4 had a vote to select the denomination. There were 38 votes for Presbyterian and 8 for Episcopal. The Rev. James W. Douglas was secured and arrived in Milton in March 1826.
- 1826 First members listed: Martin P. Huntington, Mary A. Oliver, Mrs. Ann B. Owen, Mrs. Reny Carlson, Mrs. Sarah New, Miss Sally Patrick, Miss Margarette Smith—certificate number 1 from 5<sup>th</sup> Presbyterian Church of Baltimore.
- 6/11/1826 Mrs. Susan Huntington, Mrs. Sarah G. Cooke, Mr. George W. Kent, and Amey, a black woman [sic], were baptized.

10/1/1826 Martin P. Huntington and H. J. Foster ordained and installed as elders.

- 10/26/1826 Mr. William F. Hayes received on profession of faith and examination. Sicily, a black woman, belonging to Col. A. Donoho received on profession of faith and examination.
- 12/20/1826 Mr. James Holder, Miss Melinda Holder received on profession of faith and examination.
- 12/23/1826 Mrs. Sarah Jones and Mrs. Sarah Holder received on profession of faith and examination. Examined by Bro. Wm. S. Plumer [a Presbyterian minister from Danville].
- 2/17/1827 Mr. Nathan P. Carrel and Dicy, a colored woman, belonging to Dr. P.H. Thomas received on profession of faith and examination.

Mrs. Sarah Jones lately removed to Gosport, Va, dismissed to church in Norfolk.

Dicy, mentioned on the previous page was a member of Nutbush Church in Granville Co.

2/18/1827 The church, just finished, was opened with a dedicatory sermon by the Rev. Wm. S. Plumer.

Joseph, a colored member of the church in Greensboro was received into occasional communion for this year at written request of Rev. W. Carruthers.

- 3/10/1827 Mrs. Mary Dodson and Miss Lucy Dodson received on profession of faith and examination.
- 4/8/1827 23 members by exam; 2 on certificate; 2 dismissed.
- 4/21/1827 37 members; 17 added on profession of faith; 1 died; 2 dismissed. Baptisms: 10 adults, 7 infants.
- 6/2/1827 The session met at the church. Present: all the members. The pastor reported that he had conversed with Miss Delilah J. Walker, and with John A. Jones, a free man, and Nancy belonging to Mr. J. Oliver and Patience belonging to Mr. S. Dodson, who are candidates for church membership, and that he would recommend their reception which was agreed to.

11/12/1827 Resolved that John A. Jones be appointed a stated reader and instructor to the black members of the church, under the direction of the session, and that the members be requested to concur in this resolution.

Letter to be written extending a call to the Rev. Mr. [Daniel A.] Penick.

Resolved that Mr. Douglas converse with the masters and mistresses of our black members in reference to their opportunities for attending public worship; and that in future, before receiving them, a note be requested from those controlling their time, promising to them the privilege of hearing, at least, one sermon on the Sabbath.

- 12/1/1827 Miss Elizabeth Catherine Hayes received on profession of faith and examination of her experience of religion ["experimental religion"].
- 12/21/1827 Mr. H. J. Foster granted certificate of dismission. Mr. Penick elected clerk of session.

A prayer meeting at Mr. Dodson's, his youngest child and grandchild were baptized.

Mr. Douglas conversed with the member who has been absent from communion (member's name not given) and that he appears to feel correctly on the subject. ...[T]hose members who have children to be baptized are all ready to comply.

12/23/1827 Mr. Douglas took leave of the congregation.

Session met at Mr.Dodson's. His youngest child and grandchildren were baptized.

- 3/6/1828 First meeting of the Female Bible Class. Sixteen ladies present and six others have promised to attend.
- 3/13/1828 First meeting of the Male Bible Class. Eleven gentlemen attended.
- 3/21/1828 Mr. Foster (an elder) requested that his certificate of dismission be rescinded.
- 5/7/1828 Mrs. Lucy M. Lewis, Mrs. Fanny Ball received on profession of faith and examination.
- 6/22/1828 Mr. Bolton and Miss Holder were baptized.

6/28/1828 Warner M. Lewis, Willis L. Williams, William Bolton, Miss Sarah P. Holder received into membership. 7/12/1828 Miss E. Smith and Mr. Nicholas M. Lewis received on profession of faith and examination. 7/13/1828 Miss Smith and Mr. Lewis were baptized. 7/28/1828 Henry J. Foster dismissed to Presbyterian Church of Hagerstown, Md. 8/30/1828 Mr. William F. Hayes dismissed to Grassy Creek Church, Granville Co. 9/6/1828 Mr. Walton, an elder from Red House, invited to sit as a corresponding member. Mrs. Eliza Adams received on profession of faith and examination. Mrs. Susan Perkins received by letter from Presbyterian Church, Tuscumbia. Al. 9/7/1828 Wm. Adams was baptized. 9/27/1828 Mrs. Susan New departed this life about 5 o'clock in the afternoon. Her disease, a dropsy of the brain, rendered her quite deranged for several days previous to her death. Richard Bullock, Mrs. Mary P. Bullock (his wife) received on profession 10/18/1828 of faith and examination. Notes: One elder to be elected to replace Maj. James Holder who declined to serve. Mr. Warner M. Lewis was chosen. 10/25/1828 Mr. Lewis ordained and installed. 11/21/1828 Rumor charges Cicily with habitual and intemperate use of ardent spirits. Amey, a colored servant of Mr. J. McGehee charged with fornication, having been delivered of a bastard child. 10/25/1828 Warner M. Lewis ordained and installed. 12/3/1828 Neither Cicily nor Amey appeared at the appointed time. 12/20/1828 Cicily appeared before the session and the case was continued. Mrs. M. Donoho, Mr. Henderson's George, Mr. Oliver's John to be cited to appear before the session.

Amey failed to appear.

Cicily denied drinking ardent spirits to excess but said she drank sometimes so that she felt what she had drunk. She said she had received butter as a gift from George at the springhouse on a certain occasion. She did wish and endeavor to conceal the butter from her mistress and how she came by it. "...although she professed sorrow for her sins, she has not given satisfactory evidence that she had any proper sense of their heinous nature—and also that she was quite two [sic] confident of having obtained forgiveness." She was suspended.

- 12/16/1828 "Whereas, it is generally rumored and believed that Mr. George Kent, a member of this church did on Thursday last with a durk (corrected to dirk in the book) in his hand, horse-whip a Mr. John Daniel, as to authorize a civil process and an assessment of fines..."
- 12/20/1868 Cicily appeared before the session—case continued.
- 2/4/1829 Miss Louisa Hamner received on profession of faith and examination.
- 4/15/1829 40 members; 3 added on profession of faith; 1 added on certificate; 1 died.
- 6/7/01829 Heard of the death of our dear sister Louisa J. Hamner of consumption.
- 6/8/1829 Mrs. Agnes Penick received.

Cicily requested to be restored to membership. Request denied.

- 9/5/1829 Cicily again denied return to membership.
- 9/6/1829 Collection of \$5. Also a pair of gold bracelets set with pearls cost when new \$20. From Mrs. Susan Perkins.
- 12/5/1829 Mrs. E. A. Lewis and Mrs. M.A. Donoho received on profession of faith and examination.

Cicily restored to membership.

- 5/18/1830 Mr. Kent was to be cited to appear before the session.
- 5/20/1830 Mr. George Kent charged by common fame with having a fight on the Sabbath and knocking a Mr. McWaters down with a brickbat.

Several members reported that Mr. John Alston Jones, a coloured member of the church, had become a member of the Baptist Church of Raleigh.

- 3/24/1832 Statement of Nancy who had been charged with failing to attend services of the church for a period of three years. She confessed that she had absented herself from the ordinances of the church, particularly from the sacrament of the Lord's Supper for about three years and that she had vowed that she never would commune with the same church again, confessing that in these respects she had sinned—but stating at the same time that she was over-persuaded in the first instance to join the church and that she had been provoked to act the part which she had acted by very ill treatment from a certain member of this church whose character stands entirely fair.
- 4/1/1832 Dicy requested and was granted a certificate of dismission to Nutbush Church, Granville County.

Session made the following ruling and Nancy was suspended from membership until she came to the proper state of repentance. "Nancy, having been fully heard—the Session were unanimously of the opinion that Nancy, tho [sic] she confessed the charges preferred against her at the last meeting, acknowledges her guilt, & professed repentance, gave no satisfactory evidence of being a true penitent—especially as she expresses herself as determined to persist in the same course and deals freely in unfounded charges against her brethren of the same church. Therefore Resolved unanimously that Nancy be & she hereby is suspended from the sacraments of the church until she shall give satisfactory evidence of repentance.---As Nancy was not present, it was expected that the moderator inform her in a suitable manner of the judicial proceeding."

Dr. Carter, Mrs. Pugh, Mr. Faukner, Mrs. Brown, Mr. Chiles were baptized. The scene was peculiarly solemn and interesting."

	Trial of Mr.Bullock, a member of the church and brother-in-law of Warner M. Lewis, who recused himself. The charges had to do with his business dealings with others in the community. The Session believed that he had been dishonest in his transactions. Following a thorough examination of the facts with several witnesses, the verdict was that he had been caught in business failings and that promises that were made in good faith fell through.

While they mourn over their loss in his death, they do not presume to question the wisdom or the loving kindness of our Heavenly Father in taking him away. They rather find a special cause for gratitude in the goodness which spared him so long and gave him so large a share of bodily health and still more in that converting grace which brought him in early life to a saving knowledge of the truth as it is in Christ and thus inclined to enable him to spend so many years in the service of his divine Lord and Master.

They would especially bear witness to his modest worth, to his forgetfulness of self and his consideration for the comfort and feelings of others, to his clear conceptions of Truth and duty and to his steadfastness in maintaining the same. For these qualities and further for his sweetness of temper, his kindness of heart, his honesty of purpose, for his constant and punctual attendance upon the services of the sanctuary and for his habitual reverence and devotedness in the house of God, this Session would especially commend him as an example worthy to be followed.

They pray that the great Head of the Church will raise up another in his place, who shall follow him as he followed Christ.

By resolution a Copy of the above Minutes was directed to be sent to the family of the deceased and also copies to be sent to our local paper and the North Carolina Presbyterian with request that they publish the same. Session adjourned with prayer.
